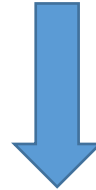

- ii. A volunteer has taken this for repair. Whilst receiving greater damage than the Revelstoke Road blue plaque it can be repaired, and this is in hand.

- iii. The damage to both blue plaques was caused by individuals using them to assist in climbing over the gates.
- iv. Repair still in progress. Two sign halves strongly rejoined with a metal plate, pins, and epoxy resin. Some lettering lost and not repairable, but luckily the text still makes sense.
- v. Remaining work to do: paint the back blue to match the sign colour, tidy up the front border. Work near completion.

## 16) Planning Matters

- i. Merton Heritage Strategy 2021-25: Development Plan
  - i. This development plan has been compiled using information supplied by Merton heritage providers including council departments, historic sites, visitor attractions and community groups. It is intended to be an evolving plan.
  - ii. May 24 update completed <https://www.friendsofwimbledonpark.org/news>
- ii. Revelstoke Road entrance improvements.
  - i. LBW 2021/0432 approved on 11<sup>th</sup> May 2021 subject to conditions.
  - ii. LBM 21/P2657 granted 25<sup>th</sup> October 2021 subject to conditions.
    1. Agreement with TfL and moving to licence stage. Access agreement between TfL & LBM to allow visitors to cross over TfL land obtained and forwarded to TfL. More chasing required.
    2. Phase 1 Northern Railway Hedge extension has been completed. National Grid provided £5000 and LBM match funded £5000.
- iii. Dam Safety planning application LBM 21/P1930 granted 14<sup>th</sup> October 2021 subject to conditions.
  - i. The dam promenade is now open, and Wimbledon Park Brook has been daylighted. Landscaping still needed.
  - ii. Revelstoke Road bund is to be landscaped.
  - iii. The dam promenade between the watersports and area is the second spillway in a flood. Spillway design is based on a free passage of water with no obstructions which could disturb the flow or catch debris. Andy Hughes (Dam Inspector) says; 'Therefore I have said no benches are allowed in this area, but I have allowed the trees to remain. Benches can be put in any area outside the spillway'.
- iv. Waterfall area
  - i. A consultation bulletin was circulated, and the response was to do more work on this project.
  - ii. Monday 7<sup>th</sup> October site meeting at waterfall with Matthew Childs Design and Water Artisans. Report expected in November.
- v. Playgrounds
  - i. This is added because of complaints about existing facilities. We have done some work on this but paused due to lack of volunteers to progress this project.
- vi. LBM local plan
  - i. Examination Of Merton's Local Plan now completed.
  - ii. As a result of the hearings into LBM's Local Plan the policy in Chapter 9 on Wimbledon Park has been rewritten and is now Chapter 8. It is no longer divided by Wi3 and is whole park again. FOWP sent in amendments including Wimbledon Park in the Wandle Valley Regional Park.
  - iii. WPRA submitted that LBM should declare:
    - iv. 1.3.1 Wimbledon Park is an important open space, designated MOL, Grade II\*, SINC and others, but it has been on the Heritage at Risk register since 2016. To address this Risk, and to ensure that public access and sporting use is perpetuated, we will secure the production of a Landscape Management Plan and further designate Wimbledon Park as a Local Green Space.

- v. FOWP support this submission. It now returns to the Inspectors.
  - vii. AELTC Wimbledon Park Project.
    - i. **Approved at GLA hearing on Friday 27<sup>th</sup> September.**
    - ii. Submission made that the 1993 covenants are material considerations for these planning applications, to be given substantial weight by all decision-makers.
    - iii. LBM Planning Committee approved WPP on Thursday 26<sup>th</sup> October. Voting 6 Labour For and 2 Liberal Democrats, 1 Conservative, and 1 Independent Against.
    - iv. LBW PAC met Tuesday 21<sup>st</sup> November and voted to refuse 7 votes to nil.
    - v. Referred to GLA.
    - vi. AELTC propose four biodiversity enhancements in Wimbledon Park (Dave Dawson). To be raised with LBM.
    - vii. *AELTC submitted a new document on public benefits in the public park which required a response, and our 10<sup>th</sup> objection has been submitted along with many others.*
  - viii. Delivering Wimbledon Park from Historic England's 'At Risk Register'.
    - i. Should concentrate on and clarify what Historic England require to remove Wimbledon Park from the 'At Risk Register'.
    - ii. These are: **The Grade II\* Registered Park and Garden (RPG) has been included in the Heritage at Risk (HAR) Register for London due to the following issues:**
      - 1. ***Uncertainty around the future [of the entire historic landscape];***
      - 2. ***The impacts of divided ownership on landscape management;***
      - 3. ***Obscured designed views; and***
      - 4. ***The deterioration of the Lake.***
    - iii. The TCBS Vision needs further discussion and consultation.
    - iv. *A start has been made with completion of Phase 1 of the Revelstoke Road entrance improvements. The Northern Railway Hedge extension. The annuals were planted by nursery children.*
    - v. *Funding will need to be raised for the next phases. Phase 2 is expected be the relocation of the prison mesh wire fencing. This is on TfL owned land. Cost around £20K.*

- i. CMP summary v05 released in May 2021.
  - ii. Wimbledon Park and Lake Masterplan December 2018 was quietly placed on LBM website:

- 19) **Sport Provision in Heritage Wimbledon Park**
- i. David Gentles has joined LBM and is responsible for sport. Meeting has taken place.
  - ii. Courts 11-20 now overseen by LTA. Netball may continue but only up to 10% of the available time.
  - iii. Now considering courts 1-5 as a MUGA (idverde continue to run courts 1-10).
  - iv. Wimbledon Park Junior Golf Programme
    - i. Wimbledon Park has an extensive Junior Academy programme with runs throughout the year and has approximately 200 participants. It takes less than 1ha of space. A request to AELTC to be allowed to continue was made and rejected on the grounds 'that this will not be viable'. This is a Community Asset that should be retained.
  - v. Volleyball
    - i. Following meeting with volleyball coaches Suzy Levy & Michael Ghelfi Saturday 8<sup>th</sup> October 2022.
    - ii. Proposed relocation of existing beach volleyball courts plus one to make 3 courts into the Old Bowling Green. To upgrade these to match standard.
      - 1. Site measuring east west and north south is 43m x 40m.
      - 2. Courts aligned east west and centred in area.
      - 3. Each court 8m x 16m with 3m margin. Total area required for each court with margin is 14m x 22m. This means 6m between adjacent courts.
      - 4. Fencing 2.4m high.
      - 5. Decking seating to east of courts.
      - 6. This is broadly in line with LBM Masterplan 2018.

  8. Existing courts have been repaired and this will delay the improvements outlined above.
- vi. Bowling Green
    - i. *Automatic watering system needed.*
  - vii. Update on:
    - i. Open water swimming-update requested from Cllr Natasha Irons.
      1. There are still concerns about safety and the need to desilt the lake. David Gentles (sport officer) to report back.
      2. Our comment: Desilting deepens the lake and isn't a reason for not allowing open water swimming. Desilting needs a cost/benefit analysis as it isn't straightforward. Details of the safety aspects still unspecified although water activity participants swim in the water.
  - viii. Pétanque boules court (funded through the Ward allocation scheme) via Wimbledon Park Cllrs,
  - ix. *Table tennis tables were provided by Wimbledon Park Community Trust the siting will be funded through parks investments.*
    - i. *Pétanque and table tennis tables are sited by the beach volleyball courts and are free to use but a booking system may be used.*
    - ii. *The downside is the loss of free to use space and FOWP will be seeking to increase this valuable facility. The greenspace loss can be set against the greenspace gain at the Northern Railway Hedge extension.*
  - x. Lighting for participation sport.
    - i. Tennis courts lights need to be made bat friendly.
    - ii. Bat friendly lighting for the beach volleyball courts to be considered. This could be in use between October to March when the bats are hibernating but not used from April to September.
    - iii. considerations include lower light installation height, modern LEDs with low light pollution, and a timer system which would mean lights are on only when players are present to set the timer, but the default is OFF rather than ON.

- i. The Capability Brown Society (TCBS) is an independent not for profit organisation with no agenda other than to stimulate debate to get the very best possible imaginative outcome for the future direction and use of the wider Heritage Wimbledon Park landscape. It aims to be proactive and imaginative setting out proposals for the wider parkland, perhaps the most intensively used multi-purpose park in London, at the same time fully providing for the conservation and improvement of the park's natural environment and ecology. This sympathetic and constructive approach will be adopted for other Brownian Landscapes in the British Isles.
  - ii. It is a corporate member of the FOWP Forum. It is not a charity.
  - iii. A Vision for Capability Brown's Wimbledon Park has been circulated.

    - iv. Catch per Unit Effort (CPUE)
    - v. In 2022 Merton Abbey Mills had the largest decline in CPUE, closely followed by Molesey Weir.
  - ii. **Report from Tony Borkowski** (EC member and angler)
    - i. London Borough of Merton, AELTC, and the Wimbledon Park Angling Club (WPAC) have recently signed a tri-partite agreement allowing angling to continue on the Lake until March 2025. One of the conditions of the agreement is for WPAC to conduct regular monthly water quality tests as far as it concerns the health and well-being of the wildlife of the Lake. To this end WPAC will sample the Lake water, on a monthly basis, for the following parameters, nitrate levels, phosphate levels, and

electrical conductivity. At the request of the EA, WPAC will also sample the levels of dissolved ammonia and dissolved oxygen. This data will be shared with all relevant parties. Note the WPAC will not be sampling the Lake water for levels of E.Coli or coliforms, which might be necessary to mitigate the health risks for sporting uses of the Lake such as swimming and water-sports activities.

- ii. So far this year no fish kills have been reported but obviously the EA and Thames Water would be alerted by WPAC if any such incidents should arise.

## 28) Public Park Management issues

- i. Access to park leaving pedestrian gates open for example initial discussions only so far.
  - i. Ross Stevens to write a report on parks open 24 hours.
- ii. Cycling in the public park –
  - i. Cllr Tony Reiss reports ‘You requested that we in Greenspaces reviewed the current cycle arrangements through Wimbledon Park. As per the attached which was sent to you back in November 2023 the only permitted cycle route, through Wimbledon Park is from Revelstoke Road up to Wimbledon Park Road entrance (and vice versa), this forms part of the London Cycle Network. As part of this review we commissioned new signage, including two new signs at Wimbledon Park Road entrance and Revelstoke Road entrance as well as paying for new thermoplastic inlays at the points of the park where cycling is not permitted.’
- iii. Cycle parking –
  - i. Cllr Tony Reiss reports ‘We don’t currently have any funds for new cycle storage solutions, but we will look to re-visit this aspect in the new financial year.’
- iv. Benches
  - i. *Brain Flasck has donated a wooden bench on behalf of FOWP. Thank you.*
  - ii. *The procedures for obtaining and maintaining wooden memorial benches is being examined.*
- v. Pines & Needles now located in Horse Close Wood car park.

  - i. Intention to discuss with Andrew Kauffman sometime.
- vii. Community Payback Team (CPT)
  - i. The CPT have received more equipment so a wider range of tasks can be accepted.

- i. Playground toilets are renovated but blockage risk remains as drainage not improved.
    - ii. Considering demolishing toilets and relocating to enlarged café in line with LBM Masterplan.
  - x. Toilets watersports.
    - i. Blockages occurring due to narrow drains.
  - xi. Recycling in WP.
    - i. Mario Silva (idverde): 'All the bins in the borough are used as general waste. Dog waste is dumped in all the bins around all the parks, and we take it to the tip where it is incinerated. We have no means to recycle even the twin bins (recycle and landfill) are used to dispose of dog waste'.
  - xii. Play areas including water play.
    - i. No action on this yet.
  - xiii. Lighting
    - i. To raise the question of lighting and bats in the public park.
    - ii. Lighting for beach volleyball.
    - iii. Dave Dawson advises: 'we have quite enough lights as it is. Apart from the stadium and stadium lane (when in use) and tennis courts, there are also fancy streetlamps along the lakeside promenade and to and from the Revelstoke Road Car Park. Many of the streetlights are left on all night regardless of whether the park is in use. We believe that this has already limited the usage of the lake by Daubenton's bat. The Great Field and Horse Close Wood are free of lighting and it would be good, not only to keep them this way, but also to curtail lights on the lakeside to occasions when the stadium or watersports centre are actually in use'.
  - xiv. Water fountains
    - i. to be investigated and requested.
  - xv. Cafe
    - i. *Café reopened Monday 24<sup>th</sup> June 2024.*
    - ii. The applicants that won the bid are Cook and Partners [www.cooksandpartners.co.uk](http://www.cooksandpartners.co.uk).
  - xvi. Glyphosate
    - i. Idverde: We are intending to plant Sarah Bouquet seed mix on the bund. Please see below the leaflet for the product.
      1. <https://www.rigbytaylor.com/wp-content/uploads/Euroflor-2022-Sarah-Bouquet-min.pdf>
      2. To get the best result for the display we need to use a glyphosate base product to minimize the competition in the soil.
    - ii. FOWP: As you know there are concerns about using glyphosate base products. This was resolved with Simon on the basis that the necessary hoeing and weeding could be undertaken by the Wimbledon Park Volunteers (WPV). This group is evolving well but we need to get a 'jobs to do list' from Tom on the parts of the park we don't take the lead on.
    - iii. Dave Dawson: It's great to have detail of the seed mix proposed.
      1. This is much more like the mix employed on the longstanding plots around the periphery of the park. It's colourful in summer and reasonably attractive to pollinators but is one of the mixes commonly called "Wildflower meadow", This is a misnomer as the species are mainly cultivars at best and exotics at worst and it is not a meadow mix but composed of tall annuals. Be quite clear, it is not what's needed either to help redress the huge losses of natural meadows in lowland UK, nor to reflect the history of the park. That said, such mixes, when successful, add to the delight felt by park users.
      2. I return, however, to ask what is the long-term plan for these bunds? The problems with establishing a seed mix this year will not go away, necessitating use of glyphosate each year. Also, my suggestion that annual cultivation will gradually erode the height of the bunds is a serious consideration.
      3. We need an agreement on the long-term vegetation of these bunds.
    - iv. Idverde: May I suggest that we proceed with the spraying and the Sarah Bouquet mix that we have already purchased for the bund and agree the long term plan, with LBM, for the bund in the next few months. If the decision is to plant whips on it, to hide the car park, that could be completed in the autumn anyways.
    - v. Dave Dawson: Yes, I agree.
